DEMYSTIFYING THE EU DATA SPACE

On 3 February 2025, Luca Pani, FACILITATE coordinator, delivered a comprehensive keynote presentation exploring the challenges and opportunities of the **European Health Data Space**. His talk provided a deep dive into the EU institutions involved, their key legislations and initiatives, and the crossinstitutional tensions shaping the data-sharing landscape. With a global perspective, he compared the divergent approaches of the EU and the US, highlighting key differences between FDA's remit and EU data governance. The discussion also featured real-world examples, including the work of FACILITATE in shaping the future of patient-centered data sharing.
